



VERIFICATION OPINION DECLARATION GREENHOUSE GAS EMISSIONS

To: The Stakeholders of IQVIA

Apex Companies, LLC (Apex) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions reported by IQVIA for the period stated below. This verification declaration applies to the related information included within the scope of work described below.

The determination of the GHG emissions is the sole responsibility of IQVIA. IQVIA is responsible for the preparation and fair presentation of the GHG statement in accordance with the criteria. Apex's sole responsibility was to provide independent verification on the accuracy of the GHG emissions reported, and on the underlying systems and processes used to collect, analyze and review the information. Apex is responsible for expressing an opinion on the GHG statement based on the verification. Verification activities applied in a limited level of assurance verification are less extensive in nature, timing and extent than in a reasonable level of assurance verification.

Boundaries of the reporting company GHG emissions covered by the verification:

- Operational Control
- Worldwide
- Exclusion: Q2 locations operated by Quest Diagnostics

Types of GHGs: CO₂, N₂O, CH₄, Refrigerants

GHG Emissions Statement:

- **Scope 1:** 10,471 metric tons of CO₂ equivalent
- **Scope 2 (Location-Based):** 36,794 metric tons of CO₂ equivalent
- **Scope 2 (Market-Based):** 38,180 metric tons of CO₂ equivalent
- **Scope 3:** Business Travel: 22,884 metric tons of CO₂ equivalent
- **Year over Year Change in Emissions (2019 - 2020)¹:**
 - Scope 1: -73.3%
 - Scope 2 (location-based): -17.4%
 - Scope 2: (market-based): -18.8%

Data and information supporting the Scope 1 GHG, Scope 2 GHG and the Scope 3 GHG emissions statement were historical and, in some cases, estimated in nature.

Level of Assurance:

- Limited
- This verification used a materiality threshold of $\pm 5\%$ for aggregate errors in sampled data for each of the above indicators

GHG Verification Methodology:

Evidence-gathering procedures included but were not limited to:

- Interviews with relevant personnel of IQVIA's consultant;
- Review of documentary evidence produced by IQVIA and IQVIA's consultant;
- Review of IQVIA data and information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions; and
- Audit of sample of data used by IQVIA to determine GHG emissions.

Verification Opinion:

Based on the process and procedures conducted, there is no evidence that the GHG emissions statement shown above:

- is not materially correct and is not a fair representation of the GHG emissions data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2), and WRI/WBCSD Greenhouse Gas Protocol Corporate Value Chain Accounting and Reporting Standard (Scope 3).

It is our opinion that IQVIA has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions for the stated period and boundaries.

Statement of independence, impartiality and competence
